Safety Rules

We're excited to welcome you to your eBike experience! To ensure a safe and enjoyable ride for everyone, please take a few moments to read and follow these guidelines carefully.

You must be at least **16 years old** to use an eBike. For tours or rentals, no driver's license is required.

Before setting off, please make sure you know where eBikes are allowed to be ridden. In particular, when renting, **written permission from the rental provider** is required to ride on public roads. Please read this permission carefully before starting your ride.

The **maximum rider weight** is approximately **120 kg**. For your own safety, please take part in our safety briefing and always wear a helmet during your ride.

Please take a few minutes to **familiarize yourself with the handling** of the eBike before riding. This includes learning how to operate it, mount and dismount safely, accelerate and brake, steer, and recognize all warning signals. Ignoring warnings may result in the eBike shutting down automatically.

Stay seated and **do not dismount while riding** – keep both feet on the pedals.

During test rides or courses, please ride at **walking speed only**. Maintain a safe distance of at least **3 m** from the rider ahead and **1 m** sideways. Be alert for uneven or damaged surfaces and avoid potholes or puddles. If you're unsure about an obstacle such as a curb, please stop and walk your eBike across it.

Each eBike is designed for **one rider only** – please do not carry passengers or children.

Always **follow the instructions** of the operator or rental staff. Not following their guidance, or riding under the influence of alcohol or drugs, may result in the ride being stopped without a refund.

Please **do not hand your eBike over to others**. After finishing your ride, return it directly to the operator or rental provider.

Liability Waiver

Your safety is our priority. However, participation in eBike rides, tours, or related activities is **at your own risk**.

Participation is only allowed after you have read, understood, and signed this **Safety Rules and Liability Waiver**.

The operator or rental provider is not liable for any damage resulting from the operation of eBikes, unless such damage was caused intentionally or through gross negligence by the operator or their staff.

This exclusion does not apply to damages involving injury to life, body, or health, or the violation of essential contractual duties, if caused by the operator or their staff.

Each participant is **fully responsible** for any personal, property, or financial damage they cause through their use of the eBike.

For safety reasons, eBike use is **not permitted** for people under the influence of alcohol, drugs, or certain medications, or for those with health conditions that could pose a risk (e.g., heart problems, high blood pressure, or pregnancy).

Please always **follow the instructions** of the operator or rental staff. The operator is not liable for any damage caused by misuse, accidents, or disregard of staff instructions. Such damages may be charged to the user up to a maximum of **€ 500**.

Liability towards business customers for minor negligence and third-party claims is excluded.
